

The process itself is expected to be dislocating and time consuming no matter how well it is done. In this case, the dislocations were minimal because of the consideration and concern of Dan and his crew. In fact, the crew was always meticulous and unfailingly pleasant. We found ourselves actually looking forward to the next stage of work.

There were many details which arose unexpectedly, such as the opportunity to seclude the wireless equipment which required no consideration and did not exist 25 years ago when the house was built. There was the opportunity to replace a large main return duct which was rectangular with a slightly larger round duct resulting in quieter and more efficient air movement.


