2022 Pool Season & Member Pool Passes

Dear Avenel Homeowner,

If you were a pool member last year, you should already have a picture ID pool pass and three (3) seasonal guest passes for your household. These are permanent passes and should be kept from year to year. You will be required to present your pool pass to access the Avenel Swim and Tennis Facilities (ASTF). The use of passes will ensure that only ASTF members and their guests will use the facilities. The pass application will provide important safety information to keep on file, including emergency contacts and children's ages.

**If you still have your picture ID pool passes from last summer...**

Passes will be activated and valid for the upcoming season for all members in good standing.

**If you still have your child's picture ID pool pass, but their appearance has changed considerably...**

Send your child's picture to the ACA and have a new updated pool pass made at no charge.

**If you had picture ID pool passes and have lost or misplaced your passes...**

Members in good standing may place a check in the dropbox outside the front doors of the ACA Office for a replacement pass to be re-issued to you. Replacement passes are \$15 each, payable by check to the "ACA."

**If you are new to the community or have never applied for a picture ID pool pass previously...**

Complete the enclosed registration form and follow the directions below to receive your pool passes. Passes will be issued to members in good standing. All adult residents of the household will be required to provide proof of residency in the form of a driver's license or photo ID, or another document that confirms residency.

Note: Any child must have a parent/guardian living at the Avenel address to receive a pool pass. Pool passes will not be issued without proof of residency.

**If you are a tenant...**

Renters will be required to provide an executed copy of their lease, including an agreement that assigns the right to use the ASTF to the tenant from the owner/landlord. The assignment of use agreement is available at [Liveatavenel.com](http://Liveatavenel.com).

**To request a pool pass...**

Please follow the directions below:

1. Complete the enclosed pool pass registration form to include each family member needing a pool pass.
2. Take a picture of each member of the family.
  - a. Make sure the picture shows a clear image of the person's face with a plain background.
  - b. Save each picture as a JPG.
  - c. Save each picture by the person's name.
3. Email the enclosed registration form, pictures, and completed waiver form to [customerservice@liveatavenel.com](mailto:customerservice@liveatavenel.com) with the subject line "Pool Pass ID."

Pool passes will be delivered or available for pickup at the ACA brochure box.

## **Waiver Form**

A waiver form must be executed and returned by all patrons who intend to utilize the facility this season. The waiver form is available at [Liveatavenel.com](http://Liveatavenel.com).

In accordance with the Association's Governing Documents, the Association will suspend the right of any resident/member and/or household member who is not in good standing, defined as being thirty (30) days or more past due on their assessments and/or in violation of any community rule or regulation. Access will be reinstated when an account is reinstated to good standing status. If a member's Association dues become more than thirty (30) days past due during the pool season, or if sanctions relating to violations are issued, all passes for that household will be deactivated until the Association has been informed by the resident/member that their account has been restored to good standing and has been confirmed by the Association, at which time passes will be reactivated.
