Avenel Swim Team

We offer two options depending on skill level: to participate on the Swim Team, children must be able to swim one length of the pool unassisted; children who cannot swim or can't yet manage one length unassisted are invited to join our Pre-Team.

Our Avenel Alligators have won our division in the Country Club League two of the past three years, and many of the senior swimmers on our team have been with us since they were 6 or 7 years old. We foster a family atmosphere and endeavor to nurture relationships between children and parents alike. Please note that all participating families must volunteer at least twice per summer – we can't do it without you!

DEADLINES AND FEES: For a child to participate, an application and the fee of \$300 per child is due by May 15; after May 15, the fee is \$325 per child. The absolute deadline is Monday, May 30. SWIMMERS NOT REGISTERED BY MAY 30 CAN NOT SWIM IN THE FIRST MEET ON JUNE 9, and a second late fee of \$100.00 will be added to the \$325 fee (except for families moving into Avenel after May 1). Discounted fees are available for families with three or more children participating.

Applications are available at www.liveatAvenel.com and contain the dates for all swim meets and other important team events.

We are also seeking parents or adult guardians to train as Stroke and Turn judges or Starters. If your child is swimming or plans to swim year-round, this training will allow you to participate in their meets throughout their swim careers.

WINTER BLUES

Many of our beautiful plants have suffered through a tough winter season. Some of our Hollies, and other specimen plant material, have received severe winter burn. Leyland Cypress trees and White Pines have had some limb damage due to heavy snow and ice. In most cases, winter burned plant material will drop damaged leaves that have

been negatively impacted during the extremely low temperatures and high winds.

This will flush out new leaves during the spring. This can be a minor setback to the growth for a season, but there's no need to be concerned. Mother Nature has been working this out for many years. Limbs of the White Pines and the Leyland Cypress trees bent down by the heavy snow and ice will return to their place in the canopy structure without the need of pruning or intervention of any kind.

Winter has not only been hard on the plants this season. Our native animals have also been impacted this winter season. They have been browsing on plant material they usually would not find appealing. Most of the damage from this will fill back in during the summer.

DOOR-TO-DOOR SOLICITORS

FROM THE DESK OF ED CALDWELL, ACA SURVEILLANCE SUPERVISOR

The spring season brings an increased number of door-to-door solicitors throughout Avenel despite signage prohibiting such activity. Common types of solicitation we frequently experience include magazine sales, door/window/roof replacement services, landscaping services, pest control services, and telecommunication services.

Surveillance staff utilizes its best efforts to promptly respond to resident reports of solicitation. In most cases, solicitors comply with requests to discontinue solicitation in Avenel. When solicitors are uncooperative, unlicensed, or trespass between homes, surveillance staff will contact the Montgomery County Police for assistance. Residents should consider contacting the police directly at their non-emergency number: 301-279-8000.

The Association suggests all residents follow these basic safety tips when encountering door-to-door solicitors: Never open the door to someone that you don't know. Always use your peephole/surveillance camera to see who is at the door. Do not engage in conversation with a solicitor or other stranger through your front door, or the services offered by a solicitor.

Another related safety issue concerns open garage doors. Often valuables inside the garage or in an unlocked vehicle are in full view and can catch the attention of passersby. Surveillance staff will continue to call residents when they encounter an open garage door between 11 pm and 6 am. Avenel is fortunate that we enjoy an overall safe community. Working together to avoid crimes of opportunity play an important role in maintaining our safe environment.

FLIGHT PATH CHANGES

DCA is back to pre-COVID 19 volume, which means more overflights of the community. While it may not feel like it, we actually have fewer flights directly overhead than we did back in early 2020. Today, Air Traffic Controllers are


"shortcutting" about 20% of approaching flights during non-rush hour times - these are times of day when the arrival schedule is light and the controllers have the time and space between flights to take aircraft off of published arrival flows early and direct them to the airport. This shortcutting creates some dispersion in the airspace, which relieves some of the burden on those of us who live under/ near the published path. However, even when shortcutting, many of these approaches still fly over Avenel - they just don't fly in the exact same places. The flight paths are more random. It's worth noting that some aircraft never make it to Avenel. Some stay east of us near the Cabin John Parkway, some stay south of us over the Potomac River, and some remain over Virginia. Note: There are times of day when it feels like there is one approaching aircraft after another. These are "busy" times of day when Air Traffic Controllers must leave aircraft on the published procedures and there is no opportunity for shortcutting. This is why a new "GPS" approach procedure expected in 2023 is important for noise mitigation.

The new approach procedure is expected to start at the CIA in Langley, VA, instead of over Montgomery County (currently, the approach begins near the corner of Persimmon Tree Rd. and Country Club Dr.). When this new procedure is published, there should be a notable decrease in the number of flights over Avenel and our neighbors. So, to sum up the situation for approaches, traffic has increased at DCA, but we would have even more total flights overhead were it not for periodic shortcutting/ dispersal. **There should be noticeable improvement in late 2023**.

A year ago, the departure path that used to fly directly over Avenel was moved about a mile south to the Naval Surface Warfare Center and the Potomac River. While Avenel residents can still hear (and see) departing aircraft because they are at a high altitude and at full thrust, the southerly shift in the path resulted in a 3 dB decrease in noise for much of Avenel.

PESTICIDE LAW COMPLIANT LAWNCARE PRACTICES

FROM THE DESK OF TOM RITTER, ACA OPERATIONS MANAGER/ AGRONOMIST

As we enter our third full growing season working under the restraints imposed by the Montgomery County Pesticide Law, I have a few observations and a suggestion.

The law bans the products previously used to control broadleaf weeds, crabgrass, and yellow nutsedge in turf. We do have a chelated iron product available for broadleaf weed control which is reasonably effective, but there are currently no products available that effectively control crabgrass and nutsedge. As a result, these weeds can proliferate during the summer months, which causes a noticeable decline in the aesthetics of lawn areas with moderate to high weed populations.

The dense summer annual weed populations thin out the desirable turfgrass species, making late summer/fall aeration and seeding even more important in maintaining high-quality turf. To aid in the recovery of the lawns in the fall, the Association moved from single aerating to double aerating 50% of lawn areas in conjunction with seeding in the fall of 2020. Beginning this year, the landscape service will include double aerating and seeding 100% of lawn areas to further increase the level of recovery of the lawns. I have been quite impressed with the quick and effective recovery observed from this more aggressive approach to fall lawn renovation in both 2020 and 2021.

For those weaker turf areas in your lawn, I suggest that you consider spring aeration and seeding along with an application of an organically rich topsoil/compost product. This service is not included in the landscape contract, but it is a relatively inexpensive additional service option. 
